The Applicant/Organization fully understands that use of City of Tenino fields/parks is intended solely for the applicant on file and as such cannot be transferred or sublet to any other entity. Failure to comply will result in loss of future field use. The City of Tenino reserves the right to cancel events/games due to inclement weather or poor field conditions. Fields are reserved upon completing the checklist and this process is first come, first served. Facilities and Restrooms are to be locked each night after use.

Indemnification/Hold Harmless/Insurance

APPLICANT/ORGANIZATION shall indemnify, defend and hold the CITY and its agents, employees, and/or officers, harmless from and shall protect and defend the City, its employees, agents, council members, and volunteers at Applicant's own expense any and all claims, demands, suits at law or equity, actions, penalties, loss, damages, or costs, of whatsoever kind or nature, brought against the CITY arising out of, or in connection with, or incident to, the execution of this rental application and/or the APPLICANT/ORGANIZATION'S performance or failure to perform any aspect of this Agreement, and/or the Applicant's use of City facilities; provided, however, that if such claims are caused by or result from the concurrent negligence of the CITY, its agents, employees, and/or officers, this indemnity provision shall be valid and enforceable only to the extent of the negligence of the APPLICANT/ORGANIZATION; and provided further, that nothing herein shall require the APPLICANT/ORGANIZATION to hold harmless or defend the CITY, its agents, employees, and/or officers for damages or loss caused by the City's sole negligence.

The Applicant is required to procure and maintain for the duration of rental period insurance against claims for injuries to persons or damage to property which may arise from, or occur in connection with, the use of the Facilities and the activities of the Applicant and Applicant's guests, representatives, volunteers, and employees.

Accordingly, the Applicant shall provide proof of general liability insurance, with minimum limits of \$1,000,000 per occurrence and \$2,000,000 aggregate and name the City of Tenino as an additional insured by using ISO endorsement CG 20 11, or coverage at least as broad as determined by the City. The insurance policy shall contain or be endorsed to reflect that the Applicant's insurance coverage shall be primary insurance as respects the City. Any insurance, self-insurance, or self-insured pool coverage maintained by the City shall be excess of the applicant's insurance and shall not contribute with it.
